# Summer 2023 Awarding Arrangements



## Context –

- Continued disruption to teaching and learning in 2021/22.
- Confirmation in June that CCEA would provide **Advance Information (AI)** for timetabled examinations in Summer 2023.
- Extends to 271 examination units/components.
- Development of Advance Information based on a set of principles agreed with the Qualifications Regulator:
  - fair and accessible to all students
  - students should not be able to pre-prepare answers
  - it must not compromise the validity and reliability of the assessment and award in a subject
  - it must not adversely impact on a student's progression to higher level qualifications
  - it must allow for differentiation between candidates on the basis of performance
  - its purpose should be to guide revision

# What is Advance Information?



- Advance Information is intended to communicate, in advance, '*some of the aspects of the specification that will be assessed in the examination papers*'.
- Its purpose is to support students' preparation and revision in the period leading up to public examinations.
- It will vary across subjects to best reflect the structure and characteristics of each qualification and question paper styles.
- The information will detail the focus of particular aspects of the examination; for example, the content, contexts, texts, topics, sub-topics, themes and skills that will be assessed in the Summer 2023 examinations.
- **Advance Information will not include everything that is being assessed in each examination** e.g. synoptic questions, multiple choice.

# When will Advance Information be available?



**Advance Information** will be provided on **Monday, 27 February 2023** for all **271 examination units/components** including:

## GCSE Child Development

- Unit 1: Parenthood, Pregnancy and the Newborn Baby
- Unit 2: The Development of the Child

## GCSE Food and Nutrition

- Component 1: Food and Nutrition

## GCE Nutrition and Food Science

- AS1: Principles of Nutrition
- AS2: Diet, Lifestyle and Health
- A21: Option A: Food Security and Sustainability
- A21: Option B: Food Safety and Quality

# How Advance Information Should be Used



- Advance information can be used from the point of release.
- It can be used flexibly by centres to achieve its purpose of supporting revision. It should not, however, be used to narrow teaching and learning.
- It can be used by teachers in supporting their students' revision and referred to by students in their revision and final examination preparation.
- **It cannot** be brought into the examinations.
- It will not be at a level that allows questions to be predicted or answers prepared.

# Awarding in Summer 2023



- In the absence of public examinations in Summer 2020 and Summer 2021, the grades awarded to students in those series were higher than in pre-pandemic years.
- With the return to public examinations, qualifications regulators across the UK are keen to see a return to pre-pandemic awarding arrangements.

*“Regulators across the UK are agreed that a return to pre-pandemic arrangements as soon as possible is important, while continuing to take account of the disruption experienced by students in recent years. To that end, CCEA will continue the journey back to pre-pandemic standards in awarding its qualifications in 2023 and expects to achieve this by 2024.”* [CCEA Regulation, 18 October 2022]

- On the basis of this statement, we expect overall results at GCSE, AS and A level in 2023 to be lower than in 2022.
- The journey back to pre-pandemic standards [grade outcomes] should be completed by 2024.


